

We are the University of California, San Francisco (UCSF), ranked the #11 academic institution in the world and creator of the biotechnology industry.



This is a high touch, virtual course that consists of interactive lectures, small discussion groups, entrepreneur talks and one-on-one office hours. You can choose to attend lectures synchronously to participate in real-time discussion or view videos on your own schedule. We make interactive discussion a priority and provide many opportunities online.

#### Live online lectures -

Lectures comprise the core of this course, taught in a lively discussion format by accomplished professionals from the Silicon Valley science and medical startup world. Each guest lecturer has been chosen both for their expertise and for their ability to engage an audience. Lectures are delivered live at different times for global access. There is always an option to view the recording at your convenience. We understand our participants are busy professionals and have packaged the course appropriately.

### **Discussion groups -**

Sector-specific forums are led by seasoned mentors in each life sciences/healthcare sector: therapeutics, diagnostics, medical devices, and digital health. The discussion breaks down the lecture topic for that sector. Entrepreneurial War Stories is led by a Founder/CEO and features one or two entrepreneurs each session who describe their path to success.

## FORMAT


